APPLICATION INSTRUCTIONS

Mixing components

Should not be diluted

Surface preparation

Clean the surface from loose materials, either by brushing it off or if needed clean with cleaning agent and water. Protect glass, aluminum and other similar surfaces that could be damaged by the detergent.

Application

Use Homeenpoisto as a ready made solution, should not be diluted. Apply the product on the surface from the bottom up with a sponge, soft brush or, for large areas, with a low pressure spray equipment. Cleaning from the top down can leave streaks on the facade. Leave the solution on surface.

Note

Do not use product if weather forecasts show rain and wind during day of application or at least for the next 6 hours of application. Cover unpaved soil, sensitive plants and surfaces not to be washed with an impermeable cover fe painters fleece. Cover glass and materials which can suffer from etching effect during prolonged contact. Rinse immediately with water when splashed on uncovered surfaces.

IF ON SKIN (or hair): Remove/Take off immediately all contaminated clothing. Rinse skin with water. Immediately call a doctor.
