- As a one-component sealer, Merit Sanding is very easy to use. The lacquer is also user-friendly, as it does not contain any aromatic solvents.
- The emission level of this product fullfils the requirements of E1 calssification for surface treatment materias. The product has been tested according to the standard EN 717-1, and its formaldehyde emission rate is less than 0.124 mg/ m³ air.
- Recommended for furniture, doors and other similar wooden surfaces indoors.

Practical coverage depends on the application method, conditions and the shape and roughness of the surface to be treated.

### **Drying times**

100–120 g/m²	+23°C	+50°C
Dry to touch, after	20–30 min	10–15 min
Dry to sand, after	2–3 h	20–25 min

Stacking temperature below +35°C.

Drying and recoating times are related to the film thickness, temperature, the relative humidity of the air and ventilation.

# **Merit Sanding**

#### **APPLICATION INSTRUCTIONS**

Surface preparation Remove dust, loose particles and other impurities from the surface. Wood surfaces must

be sanded with sandpaper P150-320. Sanding prior to the next application with

sandpaper P240-400. All sanding dust must be removed.

Recommended topcoats Merit 20, Merit 30, Merit 80, Merit Topas 25, Merit Rubin 25.

**Application conditions** The surface to be treated has to be clean and dry. The moisture content of wood has to

be below 18%. During application and drying temperature of the air, substrate and the product must be over +15°C and relative humidity of the air below 80%. Good ventilation

is required to ensure optimal result. Product can be dried with or without oven.

**Application** For airless spraying, the product is thinned approximately 0–20% to the viscosity 20–40s

(DIN4). Recommended nozzle tip is 0.011"-0.015" and pressure 100-140 bar. Spray

angle shall be chosen according to the shape of the object.

For air—assisted airless spraying, the product is thinned approximately 0–20% to the viscosity 20–40s (DIN4). Recommended nozzle tip is 0.011"–0.015" and pressure 40–120 bar. Atomising air pressure should be about 2–3 bar. Spray angle shall be chosen

according to the shape of the object.

For conventional spraying, the product is thinned approximately 0-20% to the viscosity

20–40s (DIN4). Recommended nozzle tip is 1.4–1.8 mm and pressure 2–3 bar.

**VOC** The Volatile Organic Compounds amount is 640 g/litre of paint.

Maximum VOC content in ready to use paint (thinned 20% by volume) is 670 g/l.
