## **DESCRIPTION**

A two-component, durable and non-chalking semi-gloss polyurethane paint, hardener aliphatic isocyanate.

# PRODUCT FEATURES AND RECOMMENDED USES

- A time-proven, easy-to-use general purpose topcoat for constructional steelwork and machinery. The paint has a wide spectrum of colors, including metallic effects.
- Forms a durable, easy-to-clean and non-chalking topcoat with good gloss and colour retention. The paint has also been approved for use on top of intumescent coatings.
- The product has MED (Marine Equipment Directive) certificate no EUFI29-24002082-MED and is thus accepted for painting surfaces inside the ships.
- Environmental product declaration (EPD) in accordance with EN 15804+A2 & ISO 14025 / ISO 21930.

Practical coverage depends on the application method, painting conditions and the shape and roughness of the surface to be coated.

Note! The painting work should be performed and supervised according to 12944-7 if not otherwise stated in the respective technical data sheet. Excessive film thickness may result e.g. in cracking, sagging, prolonged drying time, soft film, less chemical resistance, gloss deviation, adhesion and intercoat functionality. In case the product is used otherwise than stated in the standard a written approval from Tikkurila is required.

## **APPLICATION INSTRUCTIONS**

**Surface preparation** Primed surfaces: Oil, grease, salt and dirt are removed from the surface by appropriate

means. Repair any damage to the primer coat. Note the overcoating time of primer. (ISO

12944-4)

Recommended primers Temacoat GPL-S Primer, Temacoat GPL-S MIO, Temacoat SPA Primer, Temacoat SPA

50, Temacoat RM 40, Temacoat Primer, Temacoat HS-F Primer, Temabond ST 200,

Temabond ST 300, Temadur 20, Fontecoat EP 50.

**Recommended topcoats** Temadur 90, Temadur 50, Temadur Clear, Temathane 90, Temathane PC 50, Temathane

PC 80.

**Application conditions** All surfaces must be clean, dry and free from contamination. The temperature of the

ambient air, surface and paint should not fall below +5°C during application and drying. Relative humidity of the air should not exceed 80% during application and drying. The surface temperature of steel should remain at least 3°C above the dew point. Good ventilation and sufficient air movement is required in confined areas during application

and drying.

**Mixing components** First stir base and hardener separately. The correct proportions of base and hardener

must be mixed thoroughly before use. Use power mixer for mixing. Insufficient mixing or incorrect mixing ratio will result in uneven drying of the surface and weaken the

properties of the coating.

**Application** In order to obtain an even, non-porous finish at airless spraying the viscosity should be

30-60 s DIN4.

For airless spraying, the product is thinned depending on the temperature of the components (base, hardener, thinner) and the required viscosity approximately 10–23%. Recommended nozzle tip is 0.011"–0.017" and pressure 120–160 bar. Spray angle shall

be chosen according to the shape of the object.

For conventional spraying, the product is thinned depending on the temperature of the components (base, hardener, thinner) and the required viscosity the paint approximately

10-23%. Recommended nozzle tip is 1.4-1.8 mm and pressure 3-4 bar.

For brush application product should be thinned according to the circumstances.

**Thinners** Thinner 1048, Thinner 1067, Thinner 1061

Thinner 1061 (fast) is also suitable for conventional spraying.

Cleaning of equipment Thinner 1048, Thinner 1067, Thinner 1061

VOC The Volatile Organic Compounds amount (ISO 11890) is 400 g/litre of paint mixture.

VOC content of the paint mixture (thinned 23% by volume) is 495 g/l.
